A Regular Meeting of the Board of Supervisors of Kearney County, NE was held April 3, 2018 at 9:30 a.m. in the Supervisors' Room of the Courthouse in Minden, NE. Present were Chairman Richard Schwenka and Board Members Wayne Anderson, Larry Landstrom, Roy John Nelson, William Pittner, Robert Swanson and Ross Bruning. Also present were County Clerk Myra Johnson, Melodie Bellamy County Attorney, Highway Supt. Randy Smith, Joe Anderson Zoning Admin. and Cindy Ramsey from the Minden Courier.

The Board of Supervisors took the following action:

-Approved minutes of the Board of Supervisors meeting on March 20, 2018.

-Approved the County Clerk and Clerk of the District Court Fee Reports for March, 2018.

-Approved changing the Regular Board meeting date of May 15, 2018 to May 22, 2018 due to Election Day. -Supervisors Schwenka, Anderson and Bruning will perform the jail visit after the meeting.

-Met with Joe Anderson, Zoning Admin. He reported there were no zoning permits issued during the first quarter of 2018. He discussed some zoning regulation changes that are being proposed to add solar power to the regulations. Also a new fee schedule for permits was submitted. Set a date of May 8, 2018 at 10:00 a.m. for the Public Hearing.

-Met with Randy Smith Hwy. Supt. concerning road matters. He reported that he has two open positions at the shop and he will be advertising for employment. He also discussed a Utility Permit that he received from NPPD. They have added language to our permit so he did not feel comfortable signing it. It was recommended by the County Attorney to not sign and stay with our original form.

-At 10:00 a.m. gravel bids were opened. Broadfoot Sand & Gravel, Inc.-Kearney, NE, \$5.95 Bidder's Loader or \$5.70 Kearney County's loader; Mid-Nebraska Aggregates-Gibbon, NE, \$6.04 Bidder's Loader. The Board approved all gravel bids.

-Adjourned the Board of Supervisors meeting at 10:34 a.m.
