

The Kearney County Board of Supervisors wants to limit the risk of exposure to the COVID-19 virus to its citizens and employees. As such, we want to reach out and pass on some helpful information regarding county business in light of the current COVID-19 Pandemic. We ask that any county business that can be handled by phone, online, drop off in the drop box, or the mail, be utilized so as to limit the number of people coming into the courthouse. At this time, we ask that visitors be limited to critical business only. Please do not visit the courthouse unless absolutely necessary.

Although we will be conducting business as usual, we are strongly encouraging people to stay out of the courthouse until 3/31/2020 or until the declared state of emergency is lifted, whichever is later. Please use the county's website or online resources, as well as telephone, mail, and the drop box as alternatives to in person visits.

To help accomplish this, the drop box on the east side of the Kearney County Courthouse will now be used for most county business, not just ballots. If you have a vehicle or voter registration, an early voting ballot application or other paperwork that can be dropped in the box, then we encourage you to do so rather than coming into the courthouse. The drop box will be checked daily. Items will be processed and returned, if necessary, by the USPS mail.

The Kearney County Assessor would like to remind you that Homesteads are NOT due until June 30th and Personal Property Returns are NOT due until May 1, 2020.

I strongly encourage these forms to be mailed in. If you have questions, the Kearney County staff will be in the office Monday through Friday 8:30 - 5:00. You can also call the office at 308-832-2625 and I, or one of my staff, will come downstairs to pick up forms.
