REGULAR MEETING. BOARD OF SUPERVISORS KEARNEY COUNTY, NEBRASKA September 03, 2019– 9:30 A.M.

A Regular Meeting of the Board of Supervisors of Kearney County, NE was held September 03, 2019 at 9:30 a.m. in the Supervisors' Room of the Courthouse in Minden, NE. Present were Vice Chairman Larry Landstrom and Board Members Wayne Anderson, Brent Stewart, William Pittner, Robert Swanson and Ross Bruning. Absent was Richard Schwenka. Also present were Melodie Bellamy Co. Attorney, Myra Johnson County Clerk, Joe Anderson Zoning Adm., and Cindy Ramsey of the Minden Courier.

Detailed Minutes from the Board of Supervisors Meeting are available for inspection at the County Clerk's Office.

The Board of Supervisors took the following action:

- -Approved Bills and Claims. (see below)
- -Approved the minutes from the Board of Supervisors meeting on August 20, 2019.
- -Approved the County Clerk and Clerk of the District Court Fee Report ending August 31, 2019.
- -Approved a Duplicate Payroll Check for Accelerated Receivables Solutions from 7-25-2019 for \$21.26.
- -Approved the Region 3 Behavioral Health Services Revised Budget request from the one received in June 2019 for \$17,212.41 with a suggestion of all budget requests to sent at the beginning of the fiscal year.
- -Approved the letter from Dana F. Cole & Co. concerning the budget preparation for FY19/20.
- -Discussed the vacation payout hours over 320 that is new to the employee handbook this year. Four employees were paid for a total of \$23,397.09 and two employees who left employment with the County for \$4848.31.
- -At 9:30 a.m. held a Public Hearing on the Kearney County budget for FY 2019/2020. No one appeared.
- -Approved to exceed the Restricted Funds Authority Limit by 1%.
- -Adopted a Resolution for Adoption and Appropriations for FY 2019/2020.
- -Adopted Resolution of Cash Transfer from the General Fund to the Road Fund for \$1,014,894.00.
- -Held a Special Hearing at 9:40 a.m. to set final tax request at a different amount than the prior year. No one appeared.
- -Adopted a Resolution to set a tax request at a different amount than the prior year at \$4,414,982.00 and that the Property Tax Levy to fund tax request shall be .221797.
- -Met with Joe Anderson, Zoning Admin. to discuss the expansion application to DEQ by Olsen Cattle Co. A letter will be sent to the State explaining the County's zoning rules and regulations and how they apply to this application.
- -Met with Melodie Bellamy, Co. Attorney to discuss solicitation on County property. The handbook states that no solicitation is to be conducted on County property during working hours. This has not been enforced. Officials will need to enforce it in their offices and signs will be posted on the doors.

Also discussed at that time were new charges for Coroner calls that we have not had before. The Board did not feel these should be the County's responsibility.

- -Met with Cody Wickham from D. A. Davidson concerning refunding of the Hospital Bond that has a 5 year call date in December 2019. Rates have dropped and could save the County some money. He will bring a Parameter resolution to the next meeting with more information on savings after October which is 90 days before the 5 year date.
- -Adjourned the Board of Supervisors meeting at 11:30 a.m.
