The Board of Commissioners took the following action:

- -Approved minutes of the Board of Commissioners meeting on November 21, 2023.
- -Approved Bills and Claims, Payroll and Hospital Taxes. (See below)
- -Approved the County Clerk and Clerk of the District Court Fee Reports for November, 2023.
- -Received a dividend check from NIRMA for signing the renewal for \$5,711.
- -Correspondence was received that Kearney County has been awarded a Waste Recycling Incentive Grant for up to \$29,164.00. (Tire Grant)
- -At 9:30 a.m. opened bids for the elevator modernization project. One bid was received from Schindler Elevators of Omaha, NE for \$223,427. The Board approved the bid with the exception of paying 50% up front. --Met with Randy Smith, Hwy Supt. concerning road matters. Adopted a resolution to sign the Year End Certification for NDOT. Approved the Year End Certification of County Highway Supt. appointment for 2023. Approved the Chairman to sign the Notice of Award for Sta-Bilt Construction Co. Adopted a resolution for the Highway Supt. to do a road study on vacating some streets in Keene. Randy Smith, Hwy Supt. presented his road study to the Board.
- -Met with Melodie Bellamy, Co. Attorney and Katie Kolhanic, Adams County Juvenile Diversion. Kearney County has been in a nine county Juvenile Diversion Program pooling grant dollars from the State. Ms. Bellamy proposed a Tri-County Juvenile Diversion Plan with Kearney, Phelps and Harlan Counties receiving their own grant dollars. The Board denied the Memorandum of Understanding from Adams County and signed the Tri-County Memorandum of Understanding to begin July 1, 2024.
