The Board of Commissioners took the following action:

- -Approved the County Clerk and Clerk of the District Court Fee Reports for April 2025.
- -Approved Pmt. #2 for the Fairgrounds paving project.
- -Approve the Bond for Loren Holl, Lowell Drainage District.
- -Held a Public Hearing at 10:00 a.m. to vacate a portion of U Rd 1400 Block.
