

**MINUTES OF THE

A meeting of the Kearney County Planning Commission was called to order by Chairman John Kuehn in the Assembly room of the Courthouse in Minden, Nebraska Kearney County at 7:36 pm on June 12th, 2023. Announced that a copy of the Open Meeting Act was posted on the wall for anyone that wishes to review it and all proceedings hereafter shown were taken while the meeting was open to the attendance of the public and in accordance with the Open Meeting Act.

Chairman John Kuehn asked for the applicant and anyone in favor of the applicant to come up and speak.

Jesse & Josa Wilkinson – Explained the plat lay out and what they are wanting to do. And how this is located in an area that has not been in production agriculture but has been sitting since the former turkey farm was no longer in operation.

Kevin Raun - asked since this was the former turkey production area was there any testing and/or clean up that needed to be done. Jesse Wilkinson stated that before they purchased this property, they had the wells tested that were on the property and the test all came back that the water was good and there are no other

issues with clean up that needs to be done at this time. But there are some things that they want to get cleaned up yet.

Joseph Anderson asked about the road and Jesse Wilkinson said that they are planning on a 20 to 22 road and they he has the equipment to build and maintain the road.

With no one else wanting to speak in favor of the application Chairman John Kuehn asked if there was anyone that wanted to speak against the application.
