

**MINUTES OF THE

Notice of meeting was advertised in Minden Courier, Calendar of Kearney County website. The agenda was kept continuously current at the office of the Kearney County Zoning Administrator.

A meeting of the Kearney County Planning Commission was called to order by Chairman John Kuehn in the Assembly room of the Courthouse in Minden, Nebraska Kearney County at 7:01 pm on February 28th, 2024. Announced that a copy of the Open Meeting Act was posted on the wall for anyone that wishes to review it and all proceedings hereafter shown were taken while the meeting was open to the attendance of the public and in accordance with the Open Meeting Act.

Joseph Anderson stated that Aurora Cooperative is also working with the Kearney County Roads Department on vacating some streets around the coop to allow their operation to function better.

Terry Buettner asked where the residential properties are in Keene and their vicinity to the additional operation. Lance Jelden Keene Coop manager showed board members where the residence of Keene live.

Kenin Raun asked Joseph Anderson if there were setback requirements for cemeteries? Joseph Anderson stated that there are no special setbacks for cemeteries that they are looked at the same as any other property or structure within that district.

Kyle Jensen applicant - stated that he was wanting to operate a supplemental location to his primary location that sells used cars, trailers, farm & construction equipment at 1646 32 Rd.

Joseph Anderson asked about how many vehicles that he anticipates would be on the property at a time. Kyle Jensen stated that he hopes to have no more than 30 autos there at any given time.

The board asked if he was only selling autos or if he was going to be selling other equipment too. Kyle Jensen stated he was planning on selling cars, trucks, trailers, farm and construction equipment.

Grant Newbold (1650 32 Rd) – stated the he was in favor of Kyle Jensen and what he wants to do. But he did have some concerns about people going to his house or other parts of his property when they are looking for Kyle Jensen to ask questions about cars. He would like there to be some requirements for

signage that attempts to keep people off parts of the property where they are not supposed to be and that these signs be bilingual since some of the people buying cars are not able to read or speak English.
